1. Photo and Video Consent

The Parent acknowledges that during the class, the Teacher may wish to capture photographs or videos for educational or promotional purposes. The ability to do this will be based off of parental consent.

- 2. Parent/Student Reschedule Policy
- a. Semester Payment: Payments made for the full semester (Spring or Fall) are unrefundable and cannot be rescheduled.
- b. Monthly Payment: If a student cannot attend a class that has been payed for monthly, the cost of that class may be transferred over to a class the following month.
- c. Drop-In Payment: Drop-In classes can always be rescheduled to a future class.
- b. Rescheduling: The Parent may reschedule a class with at least 24 hours notice, subject to the Teacher's availability.
- 3. Teacher Cancellation and Reschedule Policy
- a. If "Teacher" is out of town or are sick, the Teacher must let the "Parent/Student" and "Arise AZ LLC" know as soon as possible. Arise AZ LLC can help the Teacher reschedule the lesson with the Student that the Teacher is working with or Arise AZ LLC will find a substitute at parent's request.
- 4. Parent Expectations

The Parent agrees to:

- Provide supplemental materials and resources for the class.
- Ensure the student is adequately prepared for each session.

- Communicate any concerns or feedback regarding the class promptly to the Teacher and Arise AZ LLC.
- Monitor student behavior and step in to correct if needed
- IMPORTANT* Arise AZ LLC and Teacher are not responsible or liable for supervision of student during their lesson. The parent must be available for the teacher and student during the session. If that is not possible, the parent must communicate with the teacher prior to the session. The teacher is not responsible for the supervision of the student.
- 5. Tuition and Forms of Payment
- a. Tuition: The agreed upon tuition for each class is _____ per session.
- b. Payment Schedule: Payment for teaching services is billed at the end of each month and is due on the 15th of the following month. Your tuition is considered late after the 16th of each month and will access a \$15.00 late fee. For Class Wallet families, we may require proof of submission by the 15th of each month if payment has not yet been processed. Payment shall be made [Class Wallet, Arise AZ LLC Invoice, credit card, or ACH payment, Zelle].
- c. Parent is responsible for confirming dates of sessions listed on each invoice before paying.
- 6. Student Expectations

The student agrees to:

- Attend all scheduled classes promptly.
- Complete assigned work and practice exercises between sessions.
- Respect the Teacher's instructions and maintain a positive attitude towards learning.
- Have materials and supplies ready and available for session.

7. Dress Code for PE and Dance Classes

- a. PE Dress Code: Students must arrive to class dressed in athletic clothing and tennis shoes. They also need to bring a water bottle.
- b. Dance Dress Code: Students must arrive to class dressed in comfortable athleticwear with cotton socks or ballet shoes. Their hair must be pulled back and away from their face. All students must also bring a water bottle.

8. Parental Agreement

In consideration for being allowed to participate in this program, I release from liability and waive my right to sue Arise AZ, LLC, their employees, officers, volunteers and agents (collectively "Arise AZ") from any and all claims and causes of action, including, without limitation, claims for negligence, resulting in any physical injury or illness (including death), or economic loss I may suffer or which may result from my participation in this program, or any events incidental to this program.

I agree to hold the Arise AZ harmless from any and all claims and causes of action, as well as all loss or damage to my personal property, liabilities and costs, including attorney's fees, as a result of my (child's) participation in this program, and any events incidental to this program. If the Arise AZ incurs any of these types of expenses, I agree to reimburse Arise AZ.
